



## 2023-2024 Parent FAFSA Refusal

### General Information:

All dependent students are required to provide parental information. This form must be submitted in cases where parents have ended financial support of the student or refuse to provide their information on the student's FAFSA. *Please Note: If approved, the student would qualify for unsubsidized loans only.*

### Documents Required:

1. The 2023-2024 Free Application for Federal Student Aid (FAFSA) must have been completed by the student and the information received by Baker College, and
2. The Baker College Parental FAFSA Refusal Form, OR documentation from a 3rd party source (ex: teacher, counselor, clergy, court) is required when the parent(s) refuses to sign and date the Baker College Parental FAFSA Refusal Form.
3. The Request for Re-Evaluation of Financial Aid Eligibility form needs to be completed by the student with full explanation of parental situation.

### Persons Required to Sign the Baker College Parental FAFSA Refusal Form:

1. You, the student must sign the form.
2. Parent(s):
  - a) Your biological mother and/or father
  - b) Your legally adoptive mother and/or father
  - c) Your stepparent if your biological or adoptive parent has remarried  
*Note: Grandparents, foster parents and legal guardians are not considered parents for the purposes of the FAFSA.*
3. Additional information regarding parent signature:
  - a) If your parents are legally married and living together, both signatures are required.
  - b) If your parent has never been married and you do not know or have contact with the other parent, only one signature is needed (additional documentation may be required).
  - c) If your parents are divorced (have not remarried) or legally separated, you will need to determine the appropriate parent to complete and sign the appeal by the ranked criteria below:
    - i. Parent you have lived with more often over the past 12 months.
    - ii. Parent who provided more financial support over the past 12 months.
    - iii. Parent who provided more financial support during the most recent year you received financial support.
